Sub: Disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended from time to time

Dear Sir/Madam,

Pursuant to the provisions of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended from time to time ("Listing Regulations"), this is to intimate that the Company and Mashobra Resort Limited ("MRL"), a subsidiary of the Company have been served with a Order dated 17th November 2023 (hereinafter referred to as "the Order") passed by Hon'ble High Court of Himachal Pradesh at Shimla (hereinafter referred to as "the Authority") in Execution Petition filed by the Company and MRL and the Execution Petition filed by the State of Himachal Pradesh and others against the Company and MRL. Pursuant to the Order and the Arbitral Award dated 23rd May 2005, the State Government of Himachal Pradesh exercised the right to resume Wildflower Hall Property of MRL. In furtherance of the decision, the State Government of Himachal Pradesh had by an Executive Order dated 17th November 2023 ("Executive Order 1.") taken over the Wildflower Hall property and the hotel operated by MRL on 18th November 2023.

On receipt of the Order and the Executive Order, the Company preferred an appeal challenging the Order and obtained a stay order dated 18th November 2023 ("Stay Order") from Hon'ble High Court of Himachal Pradesh, Shimla on 18th November 2023, against the implementation of the Executive Order 1. While granting the stay, Hon'ble High Court of Himachal Pradesh observed that the Court while deciding the objections of the parties vide Order dated 17th November 2023 has specifically required the State to reveal its option whether the State intends to resume the property by taking its possession in terms of the award or not. The State has been granted time for such purpose till 15th December 2023 but the State officials are stated to have taken action by issuance of Executive Order and as a consequence thereof have initiated action by visiting the hotel premises in the morning of 18th November 2023. The Hon'ble High Court further observed that since the execution petitions filed by both the sides are still pending before this Court, the Award passed by the learned Arbitrator has to be executed in terms of the directions passed by the Himachal Pradesh High Court and not by the parties themselves. In this view of the matter, the High Court of Himachal Pradesh stayed the further execution of Order till further orders. The High Court also clarified that the respondent State shall not interfere in the day-to-day management and possession of the hotel.

Consequent upon the Stay Order, the Tourism Department, Government of Himachal Pradesh issued an Executive Order dated 18th November 2023 ("**Executive Order 2**") confirming that the further operation of the Executive Order 1 dated 17th November 2023 is suspended till further orders and accordingly the officers deputed to resume the Wildflower Hall property are directed to vacate the premises forthwith.

The Company is filing the requisite details of the Order, the Executive Order and the Stay Order as set out as **Annexure A** hereto pursuant to Regulation 30 of the Listing Regulations read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD1/P/CIR/2023/123 dated 13th July 2023.
