- 1 These financial results have been prepared in accordance with the recognition and measurement principles laid down in Ind AS 34 Interim Financial Reporting prescribed under Section 133 of the Companies Act, 2013 read with the relevant rules issued thereunder and the other accounting principles generally accepted in India.
- 2 The Company has no reportable segments other than hotels as per Indian Accounting Standard.
- 3 Exceptional Items represents profit on sale of Investments held in an associate company.
- 4 The Company has adopted Ind AS 115, Revenue from contract with customers, using the cumulative catch-up transition method, applied to contracts that were not completed as of 1st April 2018. Accordingly, the prior period information has not been restated. Under the new standard, revenue is recognised upon the satisfaction of the performance obligations for the goods or services. Application of this standard resulted into reduction in opening reserves amounting to Rs. 11.21 crore (net of tax) and impact on the current quarter and nine months income statement amounting to Rs. 0.92 crore and 0.18 crore (net of tax) respectively.
- 5 Earnings Per Share are not annualised except for the year ended 31st March, 2018.
- 6 Figures have been regrouped or rearranged, wherever necessary.
- 7 The above Unaudited Financial Results were reviewed by the Audit Committee and approved by the Board of Directors at its Meeting held on 30th January, 2019. The Statutory Auditors have carried out a limited review of the above Financial Results.
