

Familiarisation Programme for Independent Directors of EIH Limited

Objective

In compliance with the Regulation 25(7) of the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 and Schedule IV of the Companies Act, 2013, the Company has implemented a familiarisation programme for orientation and training of Independent Directors. - At the Board Meetings held during the financial year, the Independent Directors are informed about the regulatory changes, changes in the policies of the Company, investors related grievances, CSR budget and initiatives, performance of subsidiary companies, changes in the organisational structures and material litigations.
- Quarterly presentations are made to the Directors on related party transactions and risk management systems.
